## **COST, TERMS AND CONDITIONS 2016**

### **COST**

28 nights - \$4475 per NZTA player, or \$4975 per non-NZTA players plus cost of airfare.

This price includes:

- Travel from Paris to Bordeaux to Paris
- Transport every day to and from tournaments and scheduled excursions
- 28 nights' accommodation
- All breakfasts and dinners
- All coaching support and training sessions
- French ranking affiliation

The price does not include:

- Flight tickets (estimated at \$2500 per person) although not included in the above cost, these will be booked for each player.
- Lunches
- Excursion visits (entry fees)
- Tournament fees (\$12 to \$20 euros per tournament)
- Travel insurance

### **TO APPLY FOR A PLACE**

Fill out the application form and send it in to us along with a refundable application fee of \$100 (those players who are not selected will receive a refund of this application fee). A selection of 8 players will be made from the applicants, 4 boys and 4 girls. NZTA reserves the right to make whatever selection we decide. No place is reserved until you have written confirmation. A non-refundable deposit of \$1000 for each player selected is required to confirm a place.

A further payment of \$1000 is required by 1 February 2016. The balance is due by 1 June 2016. If the balance remains unpaid at that time, NZTA reserves the right to treat the reservation as cancelled, and retain the deposit paid.

NZTA is not responsible for any other expenses incurred before or after its trip, including accommodation or transportation due to travel errors, visa or passport issues.

### **CANCELLATIONS AND REFUNDS**

In the case of written cancellation after full payment is due, the following cancellation fees apply:

Up to 91 days of departure - loss of deposit(s) and a further 30% of total tour price.

90 to 31 days of departure - loss of deposit(s) and a further 50% of total tour price.

30 - 0 days of departure, 100% of tour cost.

NZTA reserves the right to cancel any trip should the minimum number of people not be reached. The refund of all payments received from you, shall release NZTA from any liability to you.

The quoted price is in NZ dollars and based on current costs; if there is a change in cost, you will be notified with a full refund guaranteed if you choose to cancel.

### **RESPONSIBILITY**
